

Sounds of Poznań Event Regulations

§ 1 General rules

1. All persons present at Młyńska12 are required to read and comply with the rules contained in these Regulations.
2. Sounds of Poznań is not an open and publicly accessible event. Entry to Młyńska12 is a privilege reserved for persons who have an admission ticket.
3. A designated selector is responsible for checking tickets and inviting guests into the club.
4. During Sounds of Poznań, the selector/event security representative may decide to admit persons who do not have tickets but are on the VIP guest list.
5. Furthermore, Sounds of Poznań prohibits the admission of persons under the influence of alcohol, drugs, or other intoxicants, or who are behaving aggressively.
6. It is forbidden to bring drinks and food, weapons, knives and other dangerous tools, pyrotechnic or fire-hazardous materials, drugs and other intoxicants to the Sounds of Poznań event.
7. The organizer is not responsible for external factors beyond its control, such as rain, hail, or storms. Participants take part in the event at their own risk and bear the associated risks.

§ 2 Tickets and advance sales

1. Tickets are sold at advance sales points solely for the purpose of disseminating information about events, facilitating ticket office service at the entrance, and for the purpose of forecasting the number of people interested in the event. The number of tickets available for the Sounds of Poznań event is limited.
2. The organizer reserves the right to cancel the event without giving

a reason. In this case, people who bought tickets in advance are entitled to a refund for the ticket purchase. Cancellation of the event does not entitle you to any other claims except for the price of the purchased ticket.

4. The club is not responsible for events of force majeure that occur during the event, such as a disaster, fire, evacuation ordered by the police and fire department, bomb threats, and will not be obliged to refund tickets or pay compensation for other claims related to the cancellation or interruption of the event for the above-mentioned reasons.

§ 3 Safety

1. For the safety of guests, Młyńska12 has a safety policy that involves monitoring the premises with CCTV cameras and protecting guests with the help of security staff wearing appropriate ID badges.

2. Security personnel have the right to check the contents of clothing and items brought onto the premises of

Młyńska12, to issue instructions to guests regarding the improvement of the flow of people through Młyńska12, evacuation, etc.

3. In the event of a violation of the law or the regulations of Młyńska12 or destruction of the property of Młyńska12,

security personnel are authorized to decide to remove a guest from the premises of the Sounds of Poznań event, to use physical force, and to detain a person suspected of a serious violation of the law until the police arrive.

4. Guests of Sounds of Poznań are required to follow the instructions of Młyńska12 employees,

in particular Młyńska12 security personnel, Major security personnel, and selectors.

5. Guests of Sounds of Poznań are prohibited from leaving Młyńska12 with alcohol.

6. A paid cloakroom is available for Sounds of Poznań guests. A fee of PLN 50 applies for lost numbers.

Clothing of guests who have lost their numbers will not be returned on the day of the event. In the event of a lost number, clothing can be collected at the earliest on the Monday after

the event upon presentation of proof of ownership.

§ 4 Final conditions

1. Admission to the event means that the participant agrees to the free use of their image

by the Organizer for marketing purposes. Persons who do not agree to the use of their image for the above purposes are asked to report to the staff of Młyńska12 during the event.

2. Guests of Sounds of Poznań consent to voluntarily staying in an area of increased noise, which may occur at Młyńska12.

3. Persons purchasing a ticket or persons present at Sounds of Poznań without a ticket, pursuant to § 1, point 6 of these regulations, are required to familiarize themselves with the event regulations and automatically consent to the application of the Sounds of Poznań regulations to them.
